THIS TRUST DEED WITNESSTH AS FOLLOWS

1. **DECLARATION:** WHEREAS THE AUTHOR/SETTLER is the absolute owner of a sum Rs.50,000/- (Rupees Fifty Thousands Only) and She is desirous of settling of the said sum of rupees Fifty Thousands upon public and charitable Trust, subject to the provision hereinafter contained concerning the same.
2. **TRUSTEES:** WHEREAS the permanent life time trustees shall be:
 - a) Smt VANI THIMMAIAHGARI – **Founder Managing Trustee (FMT).**
 - b) Sri MANDAPATI VIJAYA BHASKAR REDDY – **Founder Trustee (FT).**
 - c) Both FMT and FT are life time Trustees
 - d) The FMT will have the right to appoint successor Founder Managing Trustee (FMT). FMT or MT has the right to appoint life time Trustees and Trustees by rotation and those are eligible for re-appointment.
 - e) In case no such successor MT is named, the order of succession for the Managing Trustee position will be the spouse, son, daughter-in-law, grand children of FMT in that order of succession.
 - f) In case no such successor is in a position to accept as MT the Trustees shall elect MT from the descendents of Planjery Family. In the event that no such person is in a position to accept as MT, the Trustees have the right to select a person capable and willing to perform the duties of MT in accordance with the objectives and rules of the Trust to uphold the reputation of the Trust.
3. **NAME OF THE TRUST:**

The name of the Trust shall be “**BASATA FOUNDATION**”. (Hereinafter referred to as the “Trust”).
4. **NATURE OF TRUST AND BENEFICIERIES OF THE TRUST:**

Nature of the Trust is Public Charitable Trust and The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion, creed or sex.
5. **JURISDICTION OF THE TRUST:**

The jurisdiction of the Trust shall be all over India. No activities of the Trust will be carried out outside India.
6. **DURATION OF THE TRUST:**

The Trust is irrevocable and will continue in perpetuity.
7. **OFFICE OF THE TRUST: ******

The office of the Trust shall be situated at Villa No 53, Plot No 53, Windsor Homes, Mokila Village, Shankarpally Mandal, R.R.District, A.P, India, or at such other place or places as the Board of Trustees may decide from time to time. Branch/ administrative offices can be opened in any part of the country for the smooth functioning of the Trust.
8. **THE OBJECTIVES OF THE TRUST/FOUNDATION:**

That the objectives of the Trust shall be wholly for the public and charitable purposes and income shall be applied for the same and accumulated in India wholly for public & charitable purposes without prejudice to generality of provisions mentioned herein. The following shall be deemed to be the principal objectives of **M/s BASATA FOUNDATION**:

a) Educational:

- i. To provide financial assistance as needed to needy individuals as well as to institutions to establish, maintain, support, acquire, run/adopt, aid/ develop, managing schools and colleges, that provide not only formal education, but also education of heritage, tradition and social values. In addition, to provide similar assistance to those promoting vocational training centers, libraries, laboratories etc., including promotion of technology, science, literature, music, culture and art, drama, fine arts, astrology and similar fields of study and other cultural educational development especially those that are becoming extinct'.
- ii. To provide either individually or through institutions, students scholarships, stipends, prizes, rewards, allowances and render other kind of monetary and non monetary aid for deserving students/individuals with a view to help them in pursuing their studies in schools, colleges, educational institutions, technical institutions, vocational training institutions or other institutions involved in promoting and training in higher education, art, music, cultural, etc., and other research or educational works in India.
- iii. To provide/facilitate the poor students either directly or through institutions by way of fee(s), laboratory fees, as well as examination fees, books, food, cloths/uniforms, stipends, medals and other needy incentives either in cash or in kind to full fill their studies, without any distinction of caste, color or creed.
- iv. To assist/provide financial incentives to teachers/educational institutions to improve their skills, knowledge, performance, talent, awareness, and for pursuing further education etc., for providing better education/awareness to the students and public in general.
- v. To provide similar financial incentives to teachers/ educational institutions, to motivate, to create awareness, promote and encourage quality education to economically weak students for effective competing and achieving academic excellence.

b) Employment to Youth & Women:

Most of the youth in the villages are unemployed, and though many try to take up the jobs are not properly trained and fail to do well in their appointed jobs. Therefore to provide help to unemployed youth to undergo training so that they may do better in their jobs, and also to find fresh opportunities that suits the capabilities and skills of the youth.

Prepare Woman for their journey in life. Focusing on providing vocational courses for those interested that train them for small scale jobs. To create awareness on Vaccinations, Earnings and saving money, Healthy diets, Pregnancy and family planning. Providing education for Woman is also a priority.

c) Health/Medical:

- i. To cater the needs of economically, socially weaker sections of the villages, hamlets, tribal and other backward areas, in promoting health awareness and provide medical aid and assistance, to promote primary and preventive health and hygiene, undertake drinking water projects etc.,

- ii. To provide financial assistance to the deserving persons for medical treatment, in any medical institutions for chronic illnesses and to support programmes organising exhibitions on health, seminars, conferences on hygiene, preventive health care programs, nutrition etc.,

- iii. To provide support for economically needy individuals for medical insurances, diagnostic services, tools and equipments like spectacles, hearing aids, wheel chairs, artificial limbs, other such support equipment and medical treatments.

d) Food and Necessities Distribution:

- i. To support, maintain or establish regular or intermittent distribution of food, cloth, medical aid etc., and annadanam programs either directly or through other institutions, for the needy in schools, orphanages, slum areas, homes, for aged, disabled and other similar areas.
- ii. To distribute blankets, clothing, utensils and other necessities to the economically weak and needy.

e) Heritage, Arts, Music, Culture support:

- i. To support economically weak and aged artists, musicians, writers, scholars and other talented individuals especially those artists in the fields that are becoming extinct with needed economic support for living assistance, to provide honorariums, monetary and non monetary incentives as well as required facilities like equipped stages, sound systems, musical instruments, sheds and other similar material needed to practice, promote, and present their talent to public at large.
- ii. To support in cash or in kind, either individuals or institutions promoting art, drama, heritage, culture, music, folk art, etc., through public performances, audio video productions, media events, creation of websites and other means.
- iii. To provide economic and other incentives for individuals or institutions that involve the younger talents in preserving, enhancing, protecting, researching, promoting heritage, culture, music, arts etc., benefiting the public at large.


f) Orphanage, old age, disability support:

- i. To establish, maintain and/or grant aid either to needy individuals or institutions like orphanages, home for the aged, Institutions and home for people with mental, visual, physical, financial & other disabilities. To support establishments working in similar relief and help to the needy, the poor and destitute people, orphans, children, widows etc., both normal and disabled.

g) Other Services:

- i. To support individuals/ institutions conducting sports, games and cultural competitions, helping to recognize talents and provide assistance as needed to enhance their talents for both normal and people with disabilities.
- ii. To establish support run and maintain institutions as well as to support individuals involved in animal welfare/ protection through research, caring etc, as well as provide veterinary services including surgical support to animals, like cows, dogs, horses, elephants, monkeys etc.
- iii. To support maintain individuals and/or institutions involved in up-liftment of down trodden rural and tribal women, promoting higher education and employment support for children and women, helping prevent child labour, as well as to support woman welfare schemes in general and to conduct and/or support organizations in performing mass weddings etc., for economically weak.

- iv. To financially support needy/ economically weak families of the deceased persons for the funeral services of the dead bodies and also to construct, repair, support, cemeteries, burial grounds, crematoriums etc., without caste, creed or religion.
- v. To support or to undertake relief operations, assistance in cash or in kind, to the people affected from natural disasters like famine fire, flood, earthquake tsunami etc and conduct and/or participate with other organizations in providing assistance in re-building of infrastructure, medical care centers, rebuilding housing, supplying vocational tools lost in such calamities and other needy support either to individuals and/or through organizations.
- vi. To support individuals or institutions involved in public interest projects like promoting environmental protection, encouraging plantations including medicinal plants for greenery and health in general, promotion of usage of bio-degradable environmental friendly products and other similar programmes that are helpful to the society in general.
- vii. create awareness on basic Hygiene, Conservation of Water and electricity, planting trees, keeping our surroundings clean by using toilets, and by not littering. Long term plan includes providing facilities like market place, building hospital and making playground.

9. **MANAGEMENT:**

a) **Board of Trustees:**

- i. All the Trustees will be collectively known as Board of Trustees.
- ii. The Trust shall be managed by the Board of Trustees.
- iii. The Board of Trustees shall consist of MT and T/Trustees.

b) **Succession:**

The succession shall be in accordance with the section on Trustees mentioned in point Nos. 2 a to 2 f as mentioned above under Trustees.

- c) That the maximum number of Trustees shall be 9 but not less than two at any time.
- d) The life trustees shall not be liable to retire.
- e) Term for Trustees other than life trustees shall be three years of appointment and are liable to retire on the expiry of the term and are eligible for reappointment. The appointment can be made at any time but the term ends at the third Annual General Body Meeting after the appointment of the Trustee.
- f) Any Trustee, including the Managing Trustee may retire from the Trusteeship hereof by giving 30 days notice in writing of his or her intention to do so, to the FMT/MT or Board of Trustees as the case may be. After the expiry of the period of notice, the Trustee giving the notice shall cease to be a Trustee.
- g) That the Trustees are empowered to reimburse for the expenses incurred for the Trust and its activities out of their own funds
- h) **Honorary Advisors/ Members:** The MT/T and or the Board of Trustees can appoint Honorary Advisors/ Members as well as consultants to assist the activities of the Trust. The term of such appointment can be on need basis as decided by the FMT/MT. The Honorary Advisors/ Members are eligible to attend the Board Meetings on invitation only and are not eligible to vote. These Advisors/ Members/Consultants are eligible for remuneration, honorariums and actual expenses reimbursements.

i) **Cessations of Member/Trustees/Advisors:**

- i. The behavior of the members has been prejudicial or detrimental to the principles and objects of the M/s "**BASATA FOUNDATION**".
- ii. Any Trustee other than the Managing Trustees be removed from the office of Trustee by a resolution of the Board of Trustees who is having voting power, passed by two-third majority. Any Advisor/Member can be removed from the office by the Managing Trustee or the Board of Trustees with 2/3 majority.
- iii. The Trustee/ Advisory Member are not eligible to continue in the Board if he/she:
 - Has been found to be in unsound mind.
 - Tenders resignation
 - Was found guilty of misconduct or abuse of office, breach of trust activities prejudicial to the interest of the Trust.
 - Found convicted of any criminal offence, charges involving moral turpitude and sentenced by a court of competent jurisdiction.
 - Charged with misappropriation of Trust funds.
 - Found acting dishonestly or fraudulently.
 - Was declared as insolvent; and or permanently disabled.

10. **Trust Fund:**

The Trustees shall hold and stand possessed of the said amount of Rs.5,0,000/- (Rupees Fifty Thousands only) hereinafter called the Trust Fund which expression shall include the conversion thereof and/or the investments or conversions of such accumulations, additions and accretions thereof and the dividends and/or income of the said trust fund. The Trust Fund may be augmented by income from the initial fund and also by donations, grants and such other incomes as may be generated through such means as deemed fit by the trustees.

11. **Without prejudice to the generality of the above, the Trustees shall have the Administration and Powers of Board of Trustees and for the purpose of the objects of the trust and subject to the provisions of the income Tax Act and other Laws (including any statutory re-enactment or amendment thereof):**

A. MEETINGS:

- a) Trust may meet at least twice in a financial year and there shall be at least one meeting known as Annual General Meeting in a year at which the audited accounts and a report concerning the activities of the trust for the financial year to be prepared by such person or persons and in such a manner as the trustees shall direct shall be presented.
- b) Proper minutes shall be kept of the proceedings and resolutions of the meetings. All matters will be decided by majority and two trustees shall form a quorum of the Trust meeting. The Managing Trustee shall preside over all the meetings of the trustees.
- c) All decisions relating to the management and operation of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation, by electronic communication. Every such decision shall be decided by a majority of the Trustees present voting in any meeting of Board of Trustees or by the circulation, as the case may be and any action or decision of such majority shall be as valid as if it was done or made by the all Trustees. In case of tie, the MT/T shall have a casting vote.


- d) If all the Trust Board Members, who have voting power to cast at the meeting, accept, such a Meeting of Trust Board including General Meeting may be convened and conducted anywhere at designated place by video conferencing, by teleconference or by chats/electronic communication and other available communication means and such notes shall be documented. The Trust Board shall conduct board meeting at reasonable time intervals in a financial year to discuss the performance and operation of the Trust. The Board of Trustees cannot appoint any proxy to attend the meetings.
- e) All matters not provided for in this Trust deed but necessary for the Administration of the Trust of for giving effect to the objectives of the Trust, may be decided by resolution(s) made by the Board of Trustees carried by a special majority of two third of total number of the Trustees who has the voting right. In case of tie, the FMT/MT shall have a casting vote.
- f) That the funds collected for the Trust shall be utilized for carrying out the objects of the Trust or acquiring the Capital assets or constructing the building etc., for the purpose or the benefits of Trust.

B. POWERS OF TRUSTEES:

- 1) To manage the properties, assets and funds of the Trust meeting the objectives and rules of the Trust.
- 2) To buy, sell, mortgage, grant, lease, hire or otherwise of the properties of the Trust in its discretion for adequate consideration, so however any sale or alienation of Immovable properties of the trust.
- 3) To open any type of bank account (s) whether saving account, current account, fixed or otherwise, in the name of the Trust or institution (s) run by the Trust with any scheduled banks (s) or post office (s) to operate by the authorized signatures as Board of Trustees shall think fit and proper to authorized any person or persons, unless and until determined otherwise the such bank account(s) shall be opened and operated by the Founder Trustee individually or jointly with any Trustee as per separate resolution passed and approved by the MT/T.
- 4) The Trust may give gifts, bequests, endowments, and donations of any kind for the attainment and fulfillment of any of the purpose & objects of the Trust.
- 5) Subject to production of proof of payment to reimburse the travel and conveyance expenses incurred by the trust Board Members/Advisors/ Consultants to attend meetings of the Trust board as well an accommodation of boarding expenses and any other special invitees for the Board Meeting.
- 6) To appoint lawyer, advocates, consultants to file and defend suit(s) or filed for and against the Trust and or in the name of the Trust and also to file suits for financial and other disputes or dues with different parties, and to sign and execute such application petition documents for such proceedings and delegate powers to the officers(s), employees(s), staff(s), Trustees(s)/ Advisors and Consultants for such proceedings(s), as required from time to time.
- 7) The Trust will raise/collect funds by way of by accepting offerings, donations, subscriptions, endowments, gifts or voluntary contributions in India and abroad in cash or kind, properties movable and immovable, foundations, requests, from any person or persons, establishments, organizations, institutions, trusts and societies, financial grants from the Central, State and Local Authorities, through Internet payment gateway etc., for the furtherance of the aims and objectives of the society and upon such terms and conditions as the Trust may in its absolute discretion decide. To raise funds through fund raising events like books magazines, electronic mode, TV programs and any other fund rising means. To issue manual or on-line receipts for such amount received.

- 8) To maintain a contingency of volunteers and workers for developmental, welfare and service matters.
- 9) It is the duty of the Trustees to conduct the affairs of the Trust in such a manner as to comply with the laws for the time being in force applicable to charitable trusts including taxation laws applicable to such trusts, and to ensure that the public charitable and secular character of the Trust is not Jeopardized.

C. FUNCTIONS:


Without affecting the generality of powers and functions of the trustee/s to manage and administer the trust, the trustee(s) shall have the following functions:

- 1) To borrow if need be against the security of the assets of the trust by way of bank overdraft, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects and to bind the trust property for the purposes and enter into any agreement and sign such document authorizing two or more of the trustees to execute such documents, deeds, papers, etc. as may be necessary in connection therewith.
- 2) To arrange for and/or authorize the signing of or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of trustee/s by any two of the trustees to be nominated in this behalf by a resolution at the meeting of the Board of Trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- 3) To appoint or make provision for the appointment of one of the trustees or any other person as Honorary Secretary or have a sub-committee of trustee/s or have a paid Secretary or any other person or persons to attend to or supervise or conduct specified jobs or functions or entrust matters in such manner and subject to such rules and regulations as the trustees may prescribe.
- 4) To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject however to the terms of these presents in such manner and subject to such terms and conditions, rules and regulations as trustee(s) may from time to time think fit and proper.
- 5) To spend any portion of the corpus or the income of the trust for purchasing any land and/or constructing any building or buildings for and in the name of the trust for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust.
- 6) The Trust will function only as a nonprofit organisation. In case, the Trust happens to do fund raising activity with explicit profits, such business will be in accordance with the objectives of the Trust and further it would satisfy the conditions laid down in section 11(4) and proviso to section 80G(5) (i) and other provisions of the Income Tax Act, 1961.
- 7) To support, fund, donate, undertake some of the activities of recognized Charitable Organizations, registered U/s 12A of the Income Tax Act, 1961, or any other organizations which are approved by the Government and which have similar aims and objectives.

D. OFFICE BEARERS:


For the smooth running of the Trust the FMT/MT and or Board of Trustees are empowered to elect/appoint the necessary person(s)/ people as office bearers and give designation and fix salary/ remuneration or any other benefit for the services rendered by them.

E. INDEMNITY FOR TRUSTEES:

The combined liability of all the Trustees/Members/Advisors of the Trust shall be limited only to the assets of the Trust. No trustee shall be answerable or personally liable for any loss or damage arising from the administration or application of the Funds and properties of the Trust unless such loss or damage is caused through the willful default or breach of Trust or capable negligence on his/her part.

F. SUITS & PROCESSES:

The MT/T may file a suit on behalf the Trust.

G. ACCOUNTS OF THE ORGANISATION AND AUDIT:

- a) That the organisation shall maintain proper regular accounts and get them audited by qualified Chartered Accountant once in a Financial Year. They shall comply with the provisions of the laws applicable and are in force.
- b) That the accounting year of the Trust will be from 1st April to 31st March every year and the first accounts of the Trust shall close on 31st March of the year.
- c) That the Trustees are empowered to appoint a Chartered Accountant for audit of the books account of the Trust and to fix their remuneration.
- d) The accounts so maintained shall be closed every year on 31st March on which date an Income and Expenditure Account for the year and Balance Sheet as on the date of closing shall be prepared and to be placed before the meeting of Trustees after getting the same audited.
- e) That the accounts so prepared and audited shall be placed before the Annual General Body Meeting or Special Meeting of the Trustees within a period of six months of the closure of the accounts along with the report of the Auditors.

H. INVESTMENT OF FUNDS:




The Society must apply and invest the funds for all or any of the objectives of the Society and/or to accumulate the surplus portion of income and invest the same in accordance with the provisions of section 11(5) and other relevant provisions of the Income Tax Act, 1961.

I. AMENDMENTS:

- a) No Amendments or alteration shall be made in the purpose of the Association unless it is voted by 2/3 of its members present at an Annual General Meeting or Special Meeting and shall be made without the prior approval of the Director of Income Tax (Exemptions), Hyderabad.
- b) That the Board of Trustees shall call Special meeting of the Trustees for the purpose by giving 14 days notice to the Board of Trustees.

J. DISSOLUTION / WINDING UP:

- a) That the Trust can wind up its affairs if it finds it difficult to run the activities of the Trust any more but no part of the funds of the Trust and its property shall revert back to the Trustees.
- b) That in case the Trust decides to wind up the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The assets left if any shall be transferred/handed over to any trust(s) or Associations having similar aims and objects and also Registered U/s 12A of the Income Tax Act, 1961 after obtaining previous approval of Commissioner of Income Tax and in no event it shall be distributed in any manner to any of the Board of Trustees or their relatives or related concerns.

c) That the Board of Trustees shall call Special meeting of the Trustees for the purpose by giving 14 days notice to the Trustees and a resolution passed by two-thirds majority of the Trustees present shall be the requirement for the winding of the Trust.

K. RESOLVING DISPUTES:

If thereby any doubt about interpretation of this Deed or about duties, the matter shall be referred to an arbitrator chosen by a consensus among the trustees and his decision shall be accepted.

L. GOVERNING LAW AND JURISDICTION:

This Deed is subject to jurisdiction of Courts at Hyderabad and shall be governed by the laws of India.
