The aims and objectives for which the named charitable trust is established are as under:

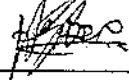

- a) To promote dharma and provide the path to the person who seek for the Truth.

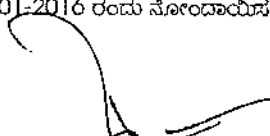

5. BOARD OF TRUSTEES

- (i) The Board of Trustees shall consist of not less than THREE and not more than SEVEN members.
- (ii) In the event of the any vacancy occurs for post of Managing Trustee or any other office bearer the next successors would be nominated by the board of Trustees from amongst themselves.
- (iii) Rest all trustees shall hold office for a fixed term of TWO years from the date of their appointment/nomination and after completion of the term, the election can be held for appointment of executive members of trust.
- (iv) The Managing Trustee shall be free to co-opt any person as trustee who may be helpful in achieving the objects of the Trust as member or for new positions if felt necessary by him to be created.

DUTIES AND OBLIGATIONS OF TRUSTEES

- (i) The Board of trustees may resolute to extend/amend/alter/modify the activities of the Trust or undertake any activity or make rules for any matter not

(ii) The Board of trustees shall have power to frame rules and regulations duties and responsibilities of each trustee, and for appointment/constitution of executive committee, sub-committee, advisory board, and for conducting any other matter connected with the administration of the trust management and shall;

a. Appoint auditor of the Trust by fixing of their remuneration for annual auditing of the trust accounts.

b. Approve and adopt Annual accounts, Annual Report, Auditors, report, Balance sheet, Income and Expenditure Account, Receipts and payments account of the Trust.

c. Accept any donations, contribution, grant or subscription in cash or in kind, from any person(s) body of persons or Trust, with or without conditions to fulfill the aims and objects of the trust.

d. Apply the whole or any part of the income of the Trust, or the Trust Fund or accumulations thereto, to any one or more of the objects of the Trust, as the Board of trustees may, in its discretion, deem fit from time to time.

s. Submit application with the Commissioner of Income tax for registration of the Trust as Charitable Trust in order to be granted necessary tax exemptions.

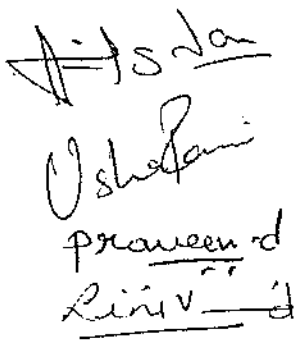

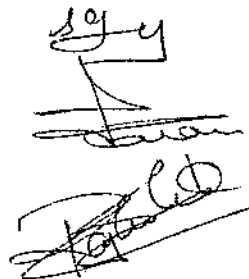

7. FINANCE OF THE TRUST

- (i) All activities of the Trust shall be in Non Profitable and shall be done on "No Profit-No Loss basis".
- (ii) The Board of Trustees shall be accountable only for such money and funds which will actually come into their hand by way of donations, contributions, and the trust funds etc.,
- (iii) The trust shall be functioning with an initial corpus of Rs.Five thousands only which will be pooled from all trustee. Thereafter, funds shall be collected through fees and subscriptions from trustees and other persons who provide donations to the Trust.
- (iv) The Trust will accept donations and contributions any form from individual or organizations, it may accept aid from Government or corporate body or raise fund by borrowing money with or without interest from Banks, Financial Institution or individuals. The borrowed money will be returned as per the terms and conditions of the carrying banks, which borrowal shall only be for purpose of/aims objects of trust.
- (v) All the incomes, earnings, movable/immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and objects as set forth

herein above and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or any other manner whatsoever to any present or the past member of the Trust or to any other person. No member of the Trust shall have any personal claim on any movable or immovable property of the Trust or make any profit, whatever, by virtue of his/her membership, and all movable/immovable properties can be transferred to any other trust having similar aims & objects only if this trust is winded up.

(vi) The Trust Fund shall be augmented by the income from initial fund and also by donations and other contribution from time to time.

(vii) The Trust fund shall not be applied to any other than those specified in Section 4 herein above unless the other objects added to the Trust Objectives.

(viii) The fund of the Trust shall be utilized for the maintenance, development and expansion of the Trust and institutions run by the Trust. Any immovable property acquired shall be registered in the name of the Trust institutions run by the Trust.

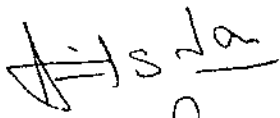
(x) The financial year of the Trust shall be from 1st of April to 31st of March of succeeding year.



(xi) The Bank account of the Trust shall be opened in any scheduled bank in Karnataka and other states of India, and at other places which board of trustees may decide later if required to smoothly manage the finance of the Trust and would be jointly operated by Managing Trustee, and other trustees authorized by trust.

(xii) Members of the Board of trustees shall not given any remuneration on account of its service to the trust except repayment of out of pocket expenses and interest on money lent or rent for premises/demises to the Trust.

8. Roles and responsibilities and powers

a) President

In addition to discharging normal duties of a trustee, the President shall preside over meeting of the Board of Trustees and in his/her absence vice president will preside. The president is authorized to sign all documents, including bank documents, institutions and other organizations, on behalf of the Board of Trustees. The President shall have all the residuary powers, not explicitly assigned to any of the other office bearers of trust.

The President is authorized to sign along with the Treasurer bank cheques, deposit release vouchers etc. The president is empowered to remove any Trustee from the Trust and its offices, if he/she finds that his/her activities are not congenial to the activities of the Trust, after passing the resolution in the board meeting of the trust.

The President & vice President responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

b) **SECRETARY:**

The Secretary shall maintain the records of the trust prepare and circulate agenda and minutes of Board of Trustee meeting for the approval of the President.

c) **TREASURER:**

The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of

The Treasurer is authorized to sign Bank cheques, application for drafts and payment instructions jointly with the President and draw money from the Bank, upto the limits defined by the Board of Trustees in their meetings. The Treasurer is responsible for safe custody of cash, bonds, securities etc., of the Trust.

9. BOARD OF MEETINGS OF TRUSTEES

- (i) The Managing Trustee/Secretary themselves or other trustee duly authorized by managing trustee may issue notices convening the meetings of Board of Trustees.
- (ii) The Board of trust shall meet at least once in 3 months either at the registered office of the or at the residence of Managing Trustee. One third members form the quorum. Ordinarily seven clear days notice shall be required for calling a meeting but in exceptional circumstances there may be an emergent meeting even at one day's notice.

(v) The minutes of the proceedings of every meeting of the board of Trustees shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

(vi) A resolution in writing circulated among all the members/trustees and signed by a majority of them shall be as valid and effectual as if it had been duly passed at a meeting of the Board of Trustees duly called and convened. There is no property in the name of trust

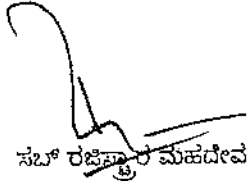
