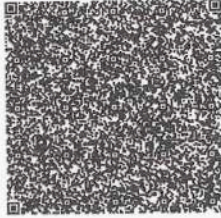

DEED OF DECLARATION OF TRUST

This **Deed of Declaration of Trust** executed at **Puducherry**, on this the **5th** day of **October, 2017 (05.10.2017)** by (1). **SHRI VED PRAKASH SHARMA**, son of Late Sri KK Sharma aged about 52 Years, residing at Flat No. 10, L'Avenir III, No. 108, Papammal Koil Street, Kuruchikuppam, Puducherry- 605012, hereinafter called the "**Author of the Trust**":

WHEREAS the Author is desirous of settling a sum of **Rs. 1,000-00 (Rupees One Thousand only)** upon Trust for the purposes hereunder mentioned;

AND WHEREAS (2). SHRI SHYAMASUNDAR KALUVE, son of Shreeshailam K.S., aged about 47 Years residing at 192 Classic Orchards Phase 1, Behind Meenakshi Temple, Bannerghatta Road, Bengaluru-560076, now come down to Puducherry; and **(3). SHRI SURESH NARAYAN SUBBARAO**, son of Sri K Subbarao, aged about 57 Years residing at No. 5, Century Park layout, Vasanth Mahal Road, Nazarbad, Mysuru-570010, now come down to Puducherry have agreed to act as Trustees of these presents, all the three of them herein below referred to as the declarants;

NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH THAT IN CONSIDERATION OF THE PREMISES;- the Author of the trust doth hereby appoint the said Trustees and transfer, assign and make over unto the Trustees the said sum of Rupees One Thousand only to have and hold the same and investments for the time being representing the same and all other sums or properties that may for the time being form part of the Trust Fund unto the Trustees absolutely and forever upon the Trust hereinafter declared, of and concerning the same:

NOW THEREFORE it is hereby declared by the declarants as follows:-

1. NAME OF THE TRUST.-

2. AREA OF OPERATION.-

The Trust shall operate all over India, particularly in Puducherry area and may open branch office at any place and function without discrimination of caste, creed and sex. No activity of the trust shall be carried out outside India.

3. THE OBJECTS OF THE TRUST.-


The main objects of the trust shall be,-

- 1.1. To enable and empower the rural communities with knowledge, leadership, and execution capabilities for holistic development and transformation of villages to: fulfill the aspirations of rural communities, break the cycle of poverty by creating new opportunities and possibilities and promote stewardship of the environment;
- 1.2. To collaborate with Governmental organizations, NGOs, academic institutions, research foundations, social enterprises and commercial organizations to gather and disseminate knowledge which would be useful for development of villages, generation of employment opportunities, building entrepreneurial and leadership skills, fostering innovation and improving the quality of life and opportunities in villages/rural areas;
- 1.3. To promote awareness, knowledge, need, and importance of environmental protection and assist in measures to help protect and preserve the environment - including but not limited to: - water management, rain water harvesting, rejuvenating traditional water bodies like wells, tanks, rivers, etc., afforestation, distribution of seeds/saplings of native and fruit bearing trees, maintain greenery, conservation of natural resources, organic farming, use of alternative energy sources, developing and using bio-degradable products etc;
- 1.4. To conceptualize, research, develop, and promote integrated technological solutions for the needs of rural communities;
- 1.5. To select, train, support, and empower budding rural entrepreneurs, innovators, and grass-root leaders in developing products and services for rural economy and eco-system;

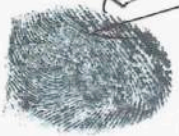

- 1.6. To identify, select, train and support 'change leaders' who will spearhead transformation of villages. These 'change leaders' are to be selected from the ranks of retiring members of military/para-military/NCC forces, progressive farmers, educated people with a desire for social change;
- 1.7. To own, establish, run, and maintain computer centers which will be used to provide education, training, awareness and access to various governmental and other services;
- 1.8. To donate either in cash or kind, to support and render financial assistance to all causes and institutions which have objects similar to the objects of the trust;
- 1.9. To extend the activities of the Trust for the purposes of social service and to make this Trust as agency for implementing various schemes and plans provided by the State or Central Government;
- 1.10. To organize workshops, seminars, symposia and conferences for provision of better and quality education to the public;
- 1.11. To work as information and advisory cell in providing knowledge, help and guidance for the formation of new associations and Trust taking up new projects in the fields of education; renewable energy; water management and conservation; organic and innovative farming; development of entrepreneurs; reforestation; setting up of small scale manufacturing units and artisan cooperatives;
- 1.12. To provide incentives, financial assistance and guidance for women for self-employment projects based on traditional arts and crafts, value added products etc;
- 1.13. To conduct special coaching classes and vocational training programs to enable the poor or marginalized children/youth to get better employment opportunities and provide assistance, clothing, meals, medical treatment and rehabilitation to uplift the socio-economic development of their families;

1.14. To collaborate with village panchayats, state and central government departments and other non-governmental organizations to establish, promote and support e-governance initiatives, services, and welfare programs;

1.15. To foster, enable, and promote a strong culture of volunteerism among citizens and to harness the power of volunteers to execute projects undertaken by the trust;

04. Utilization of Trust Income:

The funds and the income of the Trust shall be applied solely towards the promotion of the objects for which the Trust is created and no portion of it shall be utilised for payment to Trustees / Members by way of Profit, Interest, dividend etc.

05. Benefits of the Trust:

The benefits of the Trust shall ensure to all sections of the Public in India irrespective of Caste, Creed , Sex and Religion without any distinction.

06. Number of Trustees:

There shall not be less than **Two (2)** and the maximum as decided by the Trustees.

7. First Trustees:

The First Trustees of the trust are as under:

- 1) Shri Ved Prakash Sharma- Author cum Chairman.
- 2) Shri Shyamsundar Kaluve- Founder Trustee
- 3) Shri Suresh Narayan Subbarao- Founder Trustee

The Author of the Trust has the power to co-opt other Trustees in case of necessity for furthering the objects of the Trust during his life time. Post that the then Trustees will have the power to co-opt other Trustees in case of necessity for furthering the objects of the Trust. The First Trustees shall be Trustees for life.

8. Vacation of Office:

A trustee may vacate office by death, retirement, resignation, insolvency or is convicted by a court of law of an offence involving moral turpitude.

9. Delegation:

The Trustees may from time to time delegate to one or more of their body or any other person or committees such of their powers and duties, as they deem it fit, subject nevertheless to their retaining the intimate control and supervision.

10. Office Bearers:

(a) The Author of The Trust will be the first Chairman till he demits his office. Trustee Shri Ved Prakash Sharma will be the first Managing Trustee till he demits his office.

(b) The Author during his Lifetime shall appoint the Chairman and Managing Trustee. Post that the Chairman shall appoint his own successor. In the Absence of the Author and there is vacancy in the post of the Chairman / Managing Trustee the Trustees shall appoint amongst themselves a Chairman / Managing Trustee, a Secretary / a Treasurer. They will hold office for a period of three years or lesser, so decided at the Trust Meeting and shall be eligible for re-appointment.

(c) In the absence of any specific nomination to this effect Trustee Shri Shyam Kaluve shall be the next Chairman.

(d) The Chairman will have an advisory as well as a regulatory role in the trust and his/her responsibility will be to ensure that the trust's activities are in-keeping with the Vision of the Author of the trust and all activities in the name of the trust are carried out with highest integrity. His role will be in part like the compliance officer of a corporation or like the Lokpal or Ombudsman to try to ensure clean and efficient administration and partly like the CEO of a company - who has to formulate a vision and policy to guide the trust in tune with changing times and make/approve key policy decisions for the trust. It will also be his/her responsibility to ensure that the assets of the trust are managed professionally and to provide a check and balance mechanism within the trust.

(e) The person appointed as the Chairman would be a person who has

a clean record, is learned in one or more areas of activities of the trust, compassionate and well acquainted with Indian culture and values. He/She is preferably a person whose life is dedicated to serving the community selflessly with love.

(f) The Chairman will be inducted as trustee during his tenure as Chairman.. The appointment of his successor by a Chairman (post the Author's lifetime), will need the majority approval of the Board of trustees.

11. Powers of Trustees


(a) The Trustees shall have full power and authority to administer the trust, its properties and funds and to do all acts, deeds and things as are calculated to further the objects for which the trust is created. They shall be entitled to act even if their number is reduced to less than two for the purpose of filling up any vacancy of Trustees.

(b).The Trustees have the power to appoint any one of the Trustees to look after the affairs of the Trust Property in any place or places.

(c) In the event the trustees are not able to come to an unanimous opinion on any matter, The decision of the Chairman alone, if he is the Author, and the Joint decision of the Chairman and Managing Trustee otherwise, will be final in all matters concerning the trust as long as it is in line with the Objects of the Trust, and the provisions of Income Tax Act 1961.

12. Without prejudice to the generality of the foregoing the trustees shall have power for the purpose of the trust:

- a) To acquire properties by purchase, lease, grant, gift or otherwise including immovable and movables of any tenure and in case of vacant land the Trustees shall be at liberty to erect buildings there on and do all acts necessary and incidental thereto.
- b) To Sell the properties of the Trust.
- c) It shall be lawful for the trustees to pull down, renovate, rebuild, altar, adapt, improve, add to, develop or repair any immovable property comprised in the trust properties and to expend there on such moneys of the Trust fund or the income there of as they may think fit.

- d) The managing trustee with the prior approval of the Chairman shall be entitled to enter into any agreements or covenants with the owners of or persons entitled to or interested in any other properties and raise fund by loans.
- e) To enter into all contracts and to rescind the same
- f) To Invest Trust Funds in fixed Deposits with Scheduled Banks, Units Trust of India, Government Securities or any other Investments as provided for in section 11(5) of the Income Tax Act, 1961 read with section 13(i) (d) of the Income Tax Act, 1961 as amended from time to time.
- g) To receive, collect and enforce recovery of monies due to the Trust and Grant receipts and discharges thereof.
- h) To appoint, terminate suspend and otherwise deal with the employees of the Trust.
- i) To appear and act before all Government and other Public Authorities and Courts and Tribunals.
- j) To Institute and defend all suits and proceedings.
- k) The trustees shall have the power and authority to engage at their discretion remove, dismiss or suspend one or more people for service in connection with the work of the trust, trust estate, trust funds, and trust properties as they may from time to time think fit and determine their powers and duties and fix their honorariums (if any) and to require security in such instance and such amounts as the trustees may think fit
- l) The trustees shall have power in general to acquire all things and do all acts necessary to carry out the objects of the trust
- m) The trustees shall be entitled to re-imburement by the trust for all expenses incurred by them with the prior approval of the board of trustees. The board of trustees is also empowered to ratify and reimburse expenses incurred by the trustees provided they are within

the purview of the objects of the trust. The trustees shall be entitled to be indemnified by the trust against any consequences of all lawful acts done by the trustees in the course of discharge of their duties as trustees.

- n) It shall be competent for the trustees to incur expenditure from out of trust funds for travel and or stay in or outside India for promotion of objects of the trust.
- o) The trust shall be governed by a board of trustees. The unanimous decision of the board will be binding on the trust in any matter brought up before the board of trustees and shall be carried out by the Managing Trustee. In the event the board of trustees are not able to arrive at an unanimous decision, at the option of the Chairman, The decision of the Chairman alone, if he is the Author, and the joint decision of the Chairman and the Managing trustee otherwise, will be the final and shall be carried out by the Managing Trustee.
- p) To apply the properties and funds of the trust for the objects of the Trust.
- q) The trustees shall have power to accept donations from any individuals, institutions, charitable organizations, associations etc. either in cash or moveable/immoveable properties, either with or without any special conditions attached to it unless such conditions are repugnant to the objects of the trust.
- r) To establish other institutions having objects similar to those of this Trust.
- s) The trustees may deposit for safe custody any documents held by them relating to any property belonging to the Trust under these presents with any bank and may pay any sum payable in respect of the same.
- t) The trustees may buy and sell immovable property/ ies for promoting

the objectives of the Trust and also to generate required funds for meeting the trust objectives.

- u) The trust moneys shall not be invested with any private individuals, or firm or association of person or body of individuals.
- v) The entire control, regulation, management, application and administration of Trust properties whether Capital or Income, rent, interest or profit of any kind shall be in the discretion of the trustees.
- (w) The Trustees shall bear collective responsibility for activities of the trust and their actions shall have as its basis a collective decision of the board or a communication by the Managing trustee or Chairman. All actions and activities related to the Trust must be undertaken with the knowledge and approval of the Managing trustee or Chairman. The Managing Trustee and/or Chairman shall be the public interface of the trust and shall be responsible for representing the trust.

13. Amendment to Trust Deed:

No amendments shall be made which may prove to be repugnant to the provisions of section 2(15) and 11 to 13 of the Income Tax Act 1961 as read with sections of section 2(15), 11, 12 and 13 of the Income Tax 1961 and amended from time to time Further No "Amendment shall be Carried out without the prior approval of the Commissioner of Income Tax.

14. Investment:

The funds of the Trust shall be invested in the modes specified under the provisions of section 13(1) (d) read with section 11 (5) of the income Tax Act, 1961, as amended from time to time.

15. Transaction of Trustees:

The Trustees may meet as often as may be necessary for the conduct of the Activities of the Trust. The Chairman of the Trust shall preside at all meeting of the trustees and their committees. The Activities of the trust may also be transacted by circulation of papers. All decisions of the Trustees shall be by unanimous decisions except as otherwise expressly provided herein.

16. Accounts of the Trust:

The Managing Trustee shall keep proper books of accounts of the Income and Expenditure of the Trust, which shall be audited by a Chartered Accountant duly appointed.

17. Financial Year:

The Trust shall maintain or cause to maintain proper books of accounts of daily transactions as may be found necessary. The accounting period of the Trust shall be 1st April to 31st March of the corresponding year.

18. Indemnity:

The trustee shall at all time stand indemnified in respect of any act that may have been bonafide and done in good faith in respect of matters relating to the Trust.

19. Irrevocability:

The Trust formed shall be irrevocable.

20. Minutes of the Meetings:

A minute's book shall be maintained at the office by the Board of Trustees. Minutes of all meetings, appointment and entry into the office of every new trustee and all other proceedings of the board of trustee shall be entered and recorded in such minutes book and shall be signed by the Chairman of the meeting either at the conclusion thereof or at a subsequent meeting when they are duly confirmed.

21. Bye laws:


The Author of the trust may make bye laws for the management of the trust and other matters during his tenure as the Chairman. Post those Trustees may make byelaws for regulating the Management of the Trust and other matters.


22. Failure / Dissolution of the Trust:

In the event of the termination of the Trust or dissolution for any reason the Trustees shall make over or transfer the properties of the trust to a Charitable Institution or to a Charitable Trust having similar objects of this Trust and registered under Sec 11,12& 13 of the Income Tax Act, 1961as amended from time

to time or to institutional partners and /or beneficiary institutions (village panchayat, school / college and so on).

23. Powers and Duties of the office bearers of the Trust:


(a) The Author, in his role as Chairman, shall enjoy the following privileges over-riding all other provisions in the Trust deed:

01. He shall be empowered to nominate anyone as Managing Trustee or a Trustee to the Board of trustees or replace any of them;
02. Empowered to Nominate any one to succeed him (the Author) as Chairman, without need for board approval;
03. Have overriding power to approve or reject board proposals and make independent decisions in any matter, to be carried out by the trust. The decision of the Author shall be final and binding in all matters concerning the Trust;
04. Make or approve all decisions pertaining to the appointment of trustees, opening and managing bank accounts;

(b) The Chairman shall have the following responsibilities & enjoy the following powers and privileges:

01. The Chairman may approve all transactions involving immovable property, only when consented to by the Author during the life time of the Author, and post that with the consent of board;
02. Must approve/reject all decisions regarding opening and managing bank accounts presented by the managing trustee;
03. Must approve/reject all decisions on any transactions or contracts involving immovable properties, loans;
04. Must Approve/reject any new investments listed as requiring approval in the bye-laws;
05. Must Approve/reject any outflow of funds listed as requiring approval in the bye-laws;
06. May Review/veto any decisions made by trustees in the interest of the trust;
