1. The name of the Society shall be YATAN.
2. The office of the Society shall be situated in the National Capital Territory of Delhi. And at present is at the following address: C-450, Vikas Puri, New Delhi-110 018.
- 2a) *WORKING AREA: India*
3. The aim and objects for which the Society is established are as under:-

- (i) To strive to meet changing need of providing comprehensive education to develop various facets of personality and to impart education to children on the most modern lines & provide an environment congenial to growth & overall development of the children. To arrange & organize the social, cultural & educational programmes from time to time.
- (ii) To establish, manage, maintain and run Educational, Vocational, Sports and Technical Institutions anywhere in India, in Urban, Rural and backward areas and/ or to provide financial assistance and other facilities to such institutions. Emphasis would be on character building, self discipline & the development of the creative & social faculties with the aim of producing well informed & well assured people.
- (iii) To impart vocational training in vocations of household industry, semi-skilled jobs for self employment, computer science, social science, languages, fine arts, crafts, music, painting, modeling.

- (iv) To impart every knowledge, information and/ or financial assistance in maintaining day to day hygiene, healthcare, family planning, girl child birth, sanitation, environment, solar energy, rain water harvesting, village development, employment, natural resource management, mini & minor irrigation, forests, cutting of trees, wild life, moral, cultural, human & social values, consumer rights, right to information awareness, etc. specifically in rural and remote areas of India.
- (v) To establish, manage maintain and ~~run~~ ^{run} ~~houses~~, institutions for the welfare and relief of the poor, handicapped, old, orphans, widows etc. for their education / training in household and cottage industries. To promote and revive the traditional arts and crafts of India.
- (vi) To promote harmonious understanding and equal respect for all religions, cultures, races, ideologies and for that purposes to arrange cultural exchange programs, seminars, tours etc. and establish, manage, maintain and run ~~schools~~ ^{schools} co-operative communities and institutes of inter cultural understanding.
- (vii) To grant financial and all other assistance to the poor, needy and invalid persons and their families to meet their medical, social and religious obligations and to help them during emergencies such as flood, drought, war, earth-quack and rains etc.
- (viii) To promote research in the study of Indian system of medicine, homeopathy, nature cure and ancient Indian culture etc.

- (ix) To give or establish prizes for excellence in the field of Social services, human understanding, Sports, Scientific, technical etc., work / research for peace in the country.
- (x) To grant scholarships or provide financial aid to poor, needy and/ or meritorious students in the field of education and sports.
- (xi) To translate, print, publish, circulate and distribute or give financial aid for distribution of useful knowledge through literature, books, magazine, pamphlets or other printed and/ or audio-video or any other mode for the development, promotion, benefit and advancement of aims and objects of Society.
- (xii) To maintain run and construct Basti Vikas Kendra, Jan Suvidha Parisar, Roads, Foot Path, Anganvari, Libraries etc. with the help of concerned Government authorities for giving the education to the students, socially neglected people and children.
- (xiii) To subscribe or give donations financially or otherwise, to such other societies, agencies, associations or institutions who are working in the same area or involved in the activities which tend to support or aid / advance the aims and objects of the society.
- (xiv) To receive any grant, donation, fee, support and assistance in any form for the furtherance of the objects of the society.
- (xv) To purchase, lease, secure by exchange or license, hire or otherwise acquire any moveable or immovable property and any interest, easement, right and privilege necessary or alter any moveable and immovable property of the Society and undertake such other activities as may be necessary and incidental to the objects of the Society.

- (xvi) To give special attention and preferential treatment to the persons belonging to Scheduled Caste & Scheduled Tribes and of weaker section of the Society who deserve it.
- (xvii) To do all such other lawful acts, deeds and things as are incidental, subsidiary, auxiliary or conductive to the attainment of the above objects or any of them.
- (xviii) To frame bye-laws and rules and regulations for the conduct of the business of the society and its officers and employees.

No member of the society shall have any personal claim on any ~~moveable or immovable~~ properties of the society or make any ~~profits~~, whatsoever, by virtue of this membership.
