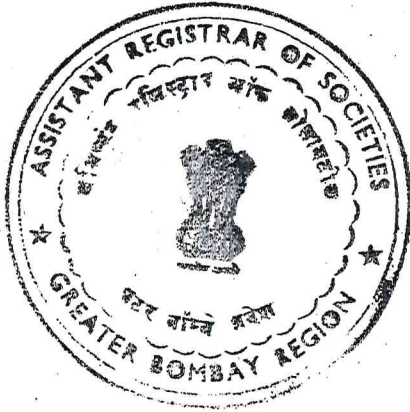

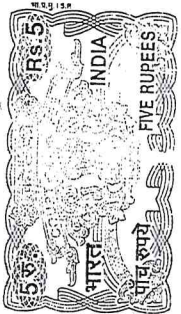
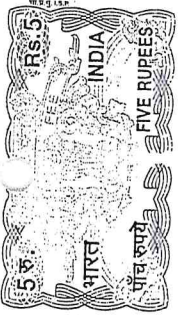
**MISCELLANEOUS APPLICATION**

That the Applicant most respectfully stated and submitted, as under :-

1. That the Applicant states that he is the President of the above said Trust known as "Rotary South Asia Society for Development and co-operation" which is registered under the provisions of Society Registration Act, 1860 and its register number is G.B.B.S.D - 396/2014 as well as Maharashtra Public Trust Act, 1950 and its register number is F – 58517.
