

**DEED OF TRUST**

TO WHOM TO ALL THESE PRESENTS SHALL COME, I MRS. BHARATI KUMAR TRIVEDI, Indian Inhabitant, hereinafter called the "SETTLOR" (Which expression shall unless repugnant to the context or meaning thereof include her heirs, executors and administrators) SEND GREETINGS. WHEREAS THE Settlor is possessed of and entitled to a sum of Rs.500/- (Rupees Fifty Hundred Only) which she is desirous of settling upon the Charitable Trusts and in the manner hereinafter mentioned.

NOW KNOW YE AND THESE PRESENTS WITNESS that I the Settlor do hereby irrevocable declare and agree that the said sum of Rs.500/- (Rupees Five Hundred Only) be held by the persons who are hereinafter named as the First Trustees of these presents upon the trust and subjected to the powers and provisions and conditions hereinafter mentioned:

1. (A) That the Charitable Trust shall be known as "**NURTURING MINDS CHARITABLE TRUST.**"

(B) The Office of the Trust shall be at such place or places in India as the Trustees from time to time think fit.
