Gautam S/o.Mr. Ajit Singh of this trust deed has separate and dedicated Rs.1001/- (Rs.One thousand one) from his own self acquire properties to this trust now on this amount his guardian, successor has not right share or privileges or any influent on the properties of the trust. The second side parties has accepted this as the properties of the trust of this properties and they have undersigned this DEED of their consent.

(3) Name of the trust, aims and mode of succession come into existence by this deed and also arrangement, conditions, and Rules for achievement of the aims of this trust are as under.

- (a) Name of this Trust : Drishti Foundation Trust

(c) Jurisdiction : Will be the whole over India

(4) Aims :-

1. To establish, run and maintain educational institute for the educational development such as Nursery, Jr.K.G., Sr.K.G., primary school, secondary school, Balwadi, Anganwadi, Arts-

commerce colleges, Law college, P.T.C. college, B.Ed college, M.Ed., M.A. Edu., M.Phil, M.C.A., M.B.A., B.P.Ed., M.P.Ed., P,4CA, B.lib., M.lib., L.L.B., H.M.D., Journalism course, Adult education classes, cradle house, night educational classes, Adhyapan mandir, gurukul, Boys and girls hostels, Ashram shalas, Uttar Buniyadi Ashram shala, Yoga school etc. and also to help the institute performing such activities.

2. To help the students taking education by way of fee, books etc. irrespective of any kind of caste, creed and also to award scholarship as well as prizes to the students. To help the needy student desirous of high education within the purview of the trust, to establish, run and maintain libraries for all sorts of development of the student, and also magazine and to publish and be published literature pertaining to it and also to undertake ancillary activities relating to it.
3. To run and maintain and also to establish home-industries, type class, tailoring classes, classes of embroidery, classes of Beauty parlour as well as to impart training free of charge. On establishing cottage industries to run its sales centers.
4. To run the Yoga educational classes for the development of the students and to impart education and training of computer to the students.
5. To open the various vocational training center for all sorts of development and to impart training of various kinds in the training centers and to issue publication relating to it and also to do preaches and lectures.
6. To undertake the educational awareness so that each people may become literate and to make attempts so that each person may start study.
7. To organize seminar as well as to make programmes for educational propaganda and to issue publication. To organize pedal tours, cycle tours, and adventures tours for the educational promotion. To organise foreign tours within the purview of the trust.
8. To assist the students by way of books, scholarships for the educational expansion and propaganda and also to encourage the students. To assist for high education free of charge and to undertake the activities for the education within the limit of the trust deed.
9. To establish, run and maintain libraries and magazine for all sorts of the development of the students and also to run and maintain ancillary activities relating to it.

10. This institute will organize and be organized learning shibir, preaches, lectures and fairs for expansion and propaganda of the knowledge.
11. To establish, run and maintain sports club, and health club for encouragement of activities of the play games and to purchase modern equipment for physical development and to health as to how to utilize and be utilized on scientific way.
12. To health the work at the indicate to injury to the person and properties during the natural calamities such as fire, heavy rain, earthquake and drought etc. to help the victims or to undertake the works received by the institute as duties.
13. He and she youths ma organize learning shibir of knowledge, science, art, artisan, music, literature etc. with the citizens of national and abroad of international level and also to make and be made attempts of correspondence.
14. To start girls schools, school, ladies college for the girls education and to conduct and maintain it. To establish vikas gruh as well as hostels for orphan and old aged women, explored girls, widow, deserted, destitute women etc. and also to handle the activities for their welfare.
15. To establish run and maintain home industries, type class, computer education center, tailoring classes, fine arts and classes of embroidery and also to impart training free of charge.
16. Will handle to activities such as activities pertaining to the problems of old aged people and also for welfare of the people and blood donation through the said institute.
17. To organize health diagnosis camp, to handle the activities of Netra yagna, Blood donation. To make an arrangement for medical treatment and also medicine on relief rate and also will run the programmes for the eradication of polio.
18. To establish, run and maintain dispensaries, hospitals, nursing home, consulting room, laboratories, health center etc. for the people of the society, for the preservation of public health and will help for such services and to give encourage of it, and also will provide the facilities of Ambulance van to the people within the purview of the trust.
19. To undertake any kind help to the physically handicapped people if the trusted may found it deemed for and to provide assistance to the needy poor people such as artificial hand, legs of cycle or to give any facilities.
20. To undertake the works for the removal of drugs from the society such as wine, gutakha, leaf, tobacco etc. to give

(7) Mode of succession in the Trustee mandal :-

There will be minimum three trustees and maximum seven trustees of this trust. At present the first managing trustee and first trustee of this trust will be the life time trustees except the managing trustee or any trustees, due to death and submission of resignation or vacancy occurred due to any reason, the remaining trustees will appoint deserved person as trustee or managing trustee vice the vacancy by majority. The tenure of duration of the appointed managing trustee or trustee vice the vacancy will be of life time. The surviving trustee will appoint an additional trustee by majority within the purview of maximum limit. The duration of the appointed an additional trustee will be of life time. The resignation of the managing trustee and also another trustees will be approved by the majority of remaining trustee.

(8) Regarding the properties of the trust :-

The than trustees of this trust will acquire the immovable and movable properties of this trust.

(9) Powers and duties of the Managing Trustee :-

- 1) Managing Trustee will call for the meeting of the trustee mandal will the place of president in such meeting and will conduct the meeting.
- 2) If there will be equal votes in the meeting at any time at such time managing trustee has privilege to caste additional vote.

- 3) Will look after over the entire activities of this trust and will issue necessary guidance and instruction will undertake day to day works of the trust.
- 4) Will appoint the employees for the functions of this trust, will decide their pay, allowances and also leave.
- 5) Will hold the representation of this trust before govt., semi-govt. and another institute, office or person and will make correspondence on behalf of the trust with his own signature.
- 6) Will issue and be issued acknowledgment for the income of trust and will obtain vouchers of the expenditures.
- 7) Will maintain and be maintained the accounts of credit and debit of this trust.
- 8) Will place the accounts of the trust in the meeting of the trustee mandal and will obtain the approval of trustee mandal on presenting the budget for the financial year.
- 9) Will get the accounts of the trust audited.
- 10) Will maintain and be maintained the resolutions passed by the trustee mandal and will implement the such resolutions.
- 11) Will preserve the properties of the trust and take action for the safety of the properties.

(10) Powers and duties of the Trustee Mandal :-

- 1) Will sell, mortgage, will give in gift and also will legally transfer the immovable properties of the trust according to the then extent law.
- 2) Will invest the money within the purview of the then extent law.
- 3) Will always be active for the achievement of the aims of this trust.
- 4) Will take decision for approval on scrutinizing the accounts and budget of this trust.
- 5) If any trustee has incurred any expenditure from his own money for the works of the trust he is entitled to reimburse the said money from the trust.

(11) Meeting and quorum of the trustee mandal :-

If it is deemed proper by the trustees will call for the meeting of the trustee mandal. The notice for calling such meeting will be issued seven days in advance to the trustees. The place, time, date and agenda of the meeting in the notice will have to be written. The quorum of the meeting will be considered as completed with the attendance of $2/3^{\text{rd}}$ of the trustees of total numbers. Meeting postponed

for want of quorum will meet after one hour on the same day. There will not be any restriction for the quorum of such meeting.

(12) Sources of income of the trust :-

The income of the trust will be collected by accepting donation, gift, fund, contribution, assistance, Grant, Subsidy, on arranging charity show etc.

(13) Resolution and proceeding book :-

Resolution presence in the meeting of the trustee mandal will be passed by the majority and it will be written in the procedure book the managing trustee and another trustees will have to undersign in it. In an ordinary circumstances resolution will be made by circular.

(14) Bank Account :-

Bank account will be opened by the signature of managing trustee and another two trustees and it financial operation will be done by the signature of any two trustee.

(15) Committees :-

As and when it is necessary trustee mandal will appoint another committees such as government committee or advisory committee for there own assistance for the work of this trust. And also will dissolve such committees. In the such committees managing trustee will always be the head of the such committees.

(16) Changes :-

If any incidence happens for changes, alteration addition in any section of the deed, the trustees will make changes, alteration, addition will be made by the unanimously of the trustees within the purview of the Bombay Public Trust Act 1950.

(17) Regarding the closure of the trust :-

Trustees will close the trust by unanimously decision. After finalizing the responsibilities of the rust, the balance properties of the trust will be entrusted to the institute having the similar aims within the provisions of law in law from time to time by decision of majority.







